#### **2007 Champs requirements**

The requirements for the 2007 champs will be the same as for 2006. It is: FdeK

- Shooter must be a paid up SADPA member
- Must have shot two leagues since the last champs
- Must have shot a classifier (Master shooters are exempt)

No exemptions will be allowed for the 2007 champs. FdeK to communicate in TDQ, also to communicate that outside clubs will host more leagues.

#### **MD Training**

More MD's will be trained over the country to take over the responsibility for their own ranges/shoots/leagues. FdeK

### **6.6 Safety & Training**

#### **SO training**

NH to get RZ to place SO training dates on SADPA website. NH / RZ

#### **SO Certificates**

In order for an SO to retain the SO status, the SO must SO six official shooters per year. NH to issue the SO certificates. NH to communicate to all shooters in TDQ that the current period will end 28 February 2008, and then yearly thereafter. NH

#### **SO Standardization**

SO workshops are important and very necessary to ensure the standards of SO's are the same.

At the champs an issue with cover was identified. It is agreed that all reloads must be done behind cover, and that a door cannot be broken with an empty gun. AdP to create information for the TDQ. AdP
