(a) Website

(b) Indemnity Form.

All members are to complete an indemnity form in conjunction with their membership renewal. This must be submitted to MH who shall keep a hard copy on file for the duration of each member's membership.

If a member does not submit the completed indemnity form with his/her renewal; the members status will be reflected as unpaid and will not be allowed to participate in SADPA shooting events until the form has been submitted to the SADPA office.

Clubs may have Indemnity Forms on hand in order to allow a paid up member to participate.

(c) SADPA 3 Gun / Multi gun

DS reports that he was in contact with IDPA USA and was informed that IDPA USA intend making public / releasing the Multi Gun Rules at the SHOT show at the end of January 2010.

DS will submit the proposed SADPA 3 Gun / Multi Gun Rules to IDPA USA for comment and approval.

(d) Outstanding raffles from 2009 IDPA Africa Champs

It was decided to scratch / cancel the outstanding raffles as the validity timeframe is about to expire.

(e) 2010 IDPA Africa Champs

Exco decided that it is not in the best interest of SADPA, its sponsors or members to hold the 2010 Africa Champs in the Cape at this time.

As SADPA grows and it becomes viable to host an International match in any of the outlying centres, this will be considered.

ASR suggested that SADPA National matches be held. This will allow outlying areas to host large shooting matches. Exco to discuss this in more detail.

Exco decided that Gauteng clubs should be asked to re-bid for the event. The hosting club will be responsible for all aspects of the match and will co-ordinate and liaise with the Exco regarding, CoF's, sanctioning of the match, SO's, entries, medals, sponsors, catering, equipment required, etc.

Bidding for the event to be closed on 22nd January 2010.

(f) Targets

GCDPC to be billed for 300 targets MH
New Lichtenberg DPC to be billed for 200 targets

(g) Clubs

AR raised the issue of financial support to clubs. This grant can/will be used to assist clubs in developing their infrastructure with regard to equipment such as pepper poppers, barricades, etc.

It was decided that Exco members would visit clubs during League shoots in 2010 to assess to what degree the various clubs need assistance with developing their equipment.

(h) SO Course

FBGC is due to present an SO Course during February 2010

NH suggested that a combined SO Course be presented; this will be made up of members from different clubs.

Courses will be presented as and when they are required.

(i) NSO

As previously discussed this will comprise a 1 day course.

Any New Shooter must be a paid up member before being allowed to participate in a SADPA event, including the Classifier that is shot as part of the NSO.

(j) SO Certificates

MH will re-issue SO certificates to SO's that have met the minimum requirement of having SO'd at 6 SADPA events during the last 12 months. MH will supply list, and NvdN will confirm SO attendance.

The certificates will be issued at the expiry date of previously issued certificates.

(k) DSS certificates
