(d) SADPA 3 Gun / Multi gun

NH raised the issue of SO training to ensure consistency and safety in 3 Gun / Multi Gun events. The consensus is that not all SO's have enough experience in the use of shotguns and rifles and need training to familiarise them with these firearms.

To ensure that members are proficient with shotguns and/or rifles they will have to attend a NSO for these firearms or prove that they have previously used these firearms in 3 Gun shooting events.

DS will submit the proposed SADPA 3 Gun / Multi Gun Rules to IDPA USA for comment and approval.
