



MINUTES OF SADPA EXCO MEETING

Held 14 September 2010

1. **Opening and apologies:** NvdN opened the meeting. Apologies from CB.

5. **General ExCo matters**

(a) Website

- ✓ SOP's – MH will collate all into one document and distribute.
- ✓ Outdated information – NvdN to update asap. Information to include sponsors, SOP's, Defensive Multigun Rules, New Shooter Information (joining process), match booklets, champs photographs.
- ✓ 2011 Calendar – ASR to send email to clubs, also request leagues and DMG leagues. NvdN to supply format.

(b) 2010 IDPA Africa Champs

De-Brief/learnings:

- Feedback received from various members; discussed and duly noted.
- Toilets were not fully functional.
- Overall reaction from participants was that the event had been well organized, prize giving and catering was first-class.
- NvdN would draw up a comprehensive de-brief which would be used for next year's event.

CHAMPS Budget:

- Had been sent to Executive committee by MH. Final totals R77607.37, expenses R75,865.00. ASR commented that cost of targets and patches had been omitted from the final budget. MH to amend.
- Entry fee of R350.00 did not include cost of shirts. A different supplier would be used if shirts procured for next years' event.

(c) 2011 IDPA Africa Champs

- Competition deadline to be brought forward by at least one week, i.e. 8 July 2011.
- COF's to be more detailed and fine tuned, and must be submitted well in advance (8 July 2011).
- Dates: 6th, 7th, 8th, 9th August 2011. 6th Saturday, 7th Sunday, 8th Monday and 9th Tuesday (Public Holiday).
- ASR to send email to clubs regarding bids to host 2011 Champs, deadline 31st October 2010.
- Champs medals – sliders had proved to be very expensive, must be investigated before next years' event. ASR will speak to Phil.
- Entry Fee to be increased to R400 or R425.00. Still to be decided.
- ASR to also send email to all regarding SADPA Nationals. Suggested timing April, October/November; with roving SO's and random squadding. Number of points for nationals = 8.
- Possible venues would be Western Cape and Gauteng.

(d) National Log

- NvdN to go back on previous league shoots, classifiers and champs, as well as the Postal Shoot for the database. Also discuss with R. Zeilinga. Log would be division based, classification independent.
- ASR to put together postal shoot for end February, 2011.

(e) Targets

- 5000 Targets purchased, and delivered to ASR property for safe keeping. Price per target would remain @ R3.00 each.

(f) DMG Rules

- NvdNest to add to website. SADPA need to run SO courses for DMG. IDPA divisions to remain as is, especially for endorsement purposes. DS to obtain a copy that confirms to SA situations.
- SAIGA12 (and other firearms with detachable magazines); load 6 in the gun, but to use one magazine only.
- Box magazines; 1 up, 5 in the magazine, no extra magazines to be used.
- DMG to be 3-gun for now.

(g) Club Development

- Lichtenburg had obtained quotation for range equipment, which was tabled and approved – cost R3858.00, would be paid by MH.

(h) Club activity DDPC and Conserve.

- ASR volunteered to discuss the situation with Michael Roberts. NvdN to send DDPC scores ?

(i) EXCO vacancies.

- Leave as is, but we need to ensure that the SOP's are available on the website before the AGM for prospective applicants. Emphasis

is on management and co-ordination, rather than doing all the work. For example, Area Co-Ordinator delegated duties to the Exco.

(j) **Finances**

- MH advised on expenses and balance in the bank account, both market link and current.
- Currently 606 paid up members.
- Dedicated Certificates issued 15 certificates during August. To date only 1 issued for September.
