- 1. Opening and apologies** – Apologies from Marge Hulleman
- 2. Confirmation of previous SAPDA ExCo minutes** – Minutes confirmed and accepted
- 3. Matters arising from previous minutes**
 - a. Website – DMG and sadpa_groups instructions, as well as joining procedure to be added asap. FAQ's also to be added. NvdN
 - b. National Log – Still outstanding to be done in time for Africa Champs - NvdN
 - c. 2011 IDPA Africa Champs and 2011 N&S Nationals – CoF's done. New members requested to participate. Exco decided to allow new shooters to participate.
 - d. Medals – AR suggests that we use standard medals, plus labels for member's own engraving. Certificates to placewinners. Nationals will be awarded 8 points.
 - e. Targets – One price from normal supplier in. Adrian to follow up with alternative supplier. Normal targets stock is running low. Adrian to confirm numbers and place order if necessary.
 - f. Clubs
 - DDPC – non-members shooting not allowed. Discipline need to be improved, and experienced shooters/Exco should attempt to hold an open day asap.
 - Dave Sheer – NH will contact them in due course to get things off the ground.
 - Zim and Finland expressed interest. Finland will be referred to IDPA HQ. Zim can be discussed from SA – DS will handover to NH.
 - Rustenburg – SO Course need to be done. AR will provide details to NH. Also for Senekal.
 - Timers – AR bought 10 timers, 2 went to ZDPC. Rest are available.
 - KSC – NvdN to contact Alan Davies.
 - g. HuntEx – too late for demo shoot, but DS will distribute pamphlets.
- 4. General ExCo. matters**

- a. IDPA Affiliation – DS advised that he sent 3 emails with various queries to IDPA HQ with no reply. Will await reply before any action or decision from SADPA. Special meeting to be called if required.
- b. Membership Numbers. – NvdN to provide more detail as to membership movements and club activity to ensure members get value for money. NH to address any issues with clubs.
- c. Rules Clarification – RWR/TacReload. *The two are only interchangeable when specified, therefore, for Classifier it'll be TacReload ONLY. FTDR - FTDRs can't be "forced" due to non-compliance with CoFs. Cover – if shooter runs dry on way to cover from cover, can go to destination cover, doesn't necessarily need to go back to original cover. Concealment - means oversize clothes that effectively hide the firearm. We don't deem it prudent if the outline of the firearm is visible, therefore, tight fitting t-shirts etc are non-compliant.*
- d. SO Courses. PDPC requested one. LM to advise of dates when he's available. To explore possibility of multiple sessions at various clubs in one go.
- e. Provincial Teams for Africa Champs – Request from Cape clubs whether teams can be entered. Exco decision is to postpone until after logs are running.
- f. Election of new Chairperson. Adrian Rosslee has been duly elected as chairman for 2011/2012.
- g. Finances – tabled and all members satisfied.
- h. Marge's salary – Exco agreed that increase to R5,000/month was effective 1 March 2011.
- i. DSS – list for March tabled and approved by Exco.
