**5. General ExCo. matters**

**a. Website**

Minutes of EXCO meetings must be loaded onto the website.

**b. National Log** – this was still an exercise under investigation, would then decide if this was viable to continue with.

**c. Targets** stored in Pretoria and the other half at GP in Gauteng. Quarter size targets were still stored in PDPC, and MCH asked that when NvdNest or DvH participated in shoots at PDPC, that they collect a minimal amount. Stock sheet had been drawn up for targets stored at PTA and JHB, MH to administer.

**d. Patches** - MH ordered 10 boxes of 30,000 @ a cost of R620.00 per box from Shooting Stuff.

**e. Safety Officer Training**: NH undertook to follow up SO Training. Best date to be agreed when most convenient to all and best attendance. Planned SO course during January, and Kimberley mid February 2012.

**f. Club Development** - Several requests have been received for financial assistance to purchase props, etc. Clubs will be allocated a budget on a paid-up membership basis at R80 per member which can then be used to buy props. SADPA to source and have props made up. All equipment to remain SADPA property for a period of at least 3 years. Props to be included in SADPA assets register (MH).

- g. **IDPA Affiliation & alternatives** - DS will discuss with IDPA in January. Agreed a payment to IDPA would be made for the increased member numbers since last payment made. MH to attend.
  
- h. **Finance** - MH tabled financials for November, which included DDS list. Accepted.

6. **ADDITIONAL ITEMS**

6.1 **Calendar** would go onto website coming week, excluding dates from GCDPC and CDPC.

6.2 **Multi Gun Rules/3 gun DMG and magazine capacity.**
