



Minutes of SADPA ExCo. Meeting

1. **Opening and apologies**

NB opened the meeting. Apologies from MH and AR

2. **Confirmation of previous SAPDA ExCo minutes** - Accepted

5. **General ExCo. matters**

a. **Website – link to forms on the website (indemnity, application form, FAQ's)**

All requested forms already loaded. DvH to link FAQ's to the forms.

b. **2012 Northern Nationals**

Well presented match. The short time from announcing the match reduced the entries that provided some problems. Costs to be looked at is the SO's cost and refreshments/meals.

If new chrony have to be bought for PDPC and the current chrony is still working, SADPA will use the old chrony for SADPA usage.

c. **2012 IDPA AFRICA Champs – August 2012**

- **Consideration of bids received JDPC and PDPC and decision hosting club**

JDPC withdrew their bid owing to short time till Champs. PDPC will host the 2012 IDPA Africa Champs

- **Criteria for participation**

Shooters need to compete in 3 matches during the past 12 months. For novices, one of the matches must have been a League/Nationals,

The shooters must have shot a classifier in the division in which they want to compete in the last 12 months (MA's exempted).

- **Entry fee**

To be confirmed by email. Looking at around R400-R450

- **Caterer**

For the prize giving – bring & braai with the club/SADPA providing pap, sous and salad.

- **Other**

Mini Targets will only be allowed at club shoots. Leagues, Nationals and Champs may not have mini targets.

d. **National Log**

NvdN presented the preliminary national log. It was decided that the log does not promote active participation in different division. The decision was made not to continue with the national log.

e. **Targets / Patches / Rule Books**

Targets and Patches do be ordered – MH to order.

A quotation will be asked for 500 A4 generic scorebooks to possibly be distributed to the clubs at cost.

The bulk order can save the clubs a lot of money on score books.

A storage unit for the targets, patches and booklets will be investigated. It will be close to MH for ease of use.

f. **Club Development - Club starter pack**

To be finalised and decided by email or at the next meeting. New clubs with a certain amount of members will receive targets/patches/timer/scorebooks when starting up.

The plan to give each club equipment/money for equipment based on members is still ongoing.

g. **Safety Officer Instructors**

Criteria to be set up together with course for SOI's – LM to investigate.

Current proposal for criteria: SO that has 1) SO'ed at a Nationals or Champs, 2) have more than 20 SO points may be nominated by their club to start the SOI process. In the process, the SO must attend a course by a SOI and present 2 SO courses with the SOI present. This will be sent to exco for decision.

h. **Finance and DDS issued.**

Finances and DSS presented by NH. Accepted.

6. **Additional Items**

6.1 **Annual General Meeting – feedback**

Went as planned with no major issue.

(a) New Chairman for 2012 /13

NH was chosen as Chairman for 2012/13. He was acting Chairman after AR resigned August 2011.

6.2 **Bob Vogel Training**

The So with the most SO points in the last 12/18 months will be chosen to attend the training sponsored by SADPA. The SO's that attended Gregg Garrett's course will not be eligible. Some SO's from outlying clubs will try to be incorporated. NvdN to compile list for approval by email.

6.3 **Timers**

Timers to arrive in 2 weeks. DS to keep up to date.

6.4 **3 gun DMG**

DvH presented the draft of the 3-Gun/DMG rules for comment. It was decided to keep the rules as is with only change to the rifle magazine capacity.

Manual rifles will only be open for lever action and pump action rifles. At club shoots, bolt actions may be used, but will not be endorsed by SADPA.

If the classifiers for shotgun and rifle are not ready when the rules are accepted, they will be developed and integrated in to the rules when possible.

The aim for the rules is to be official SADPA regional rules by end of June.

LM to structure SO training on the 3-Gun/DMG rules and practical.

6.5 **Sponsorship**

PO asked for tips on how it currently works. NvdN to send PO the information for sponsors at Champs.

PO reported that a lot of sponsors are interested.
