### 5. GENERAL EXCO MATTERS

### Action

#### a. Website:

- 1. **Range equipment** pricing – problematic unless large quantities. NH asked AR for name of the supplier. AR
- 2. **BLOEMFONTEIN** range still not accredited. Looking at an alternative Military range. NH
- 3. **DAVE SHEER** – must be added into key. Classifier held in January, No trained Safety Officers, so who was used? LM to follow up. LM  
Club has until end February to pay affiliation, list members and Confirm facilities available. NH  
SAFETY OFFICER training 9 and 10<sup>th</sup> February, invite Dave sheer. LM
- 4. **PIETERMARITZBURG** – send email reply 3 weeks later. Good Potential for this to become a SADPA club, good range. NH
- 5. Discussed Kobus Burger NCDPC, using tactical DPC trademark on Facebook.
- 6. **PREMIER** = running with another club, another discipline. Multiple Disciplines shoot at this range, IPSC supportive with equipment. DvH

**c. SAFETY OFFICER INSTRUCTORS**

- a) DMG SO training – no progress. **LM**
- b) FBGC sent details of DMG NSO, will build on this. Went very well.
- c) LM has written outline must still be tweaked, will be sent to SADPA Exco. **LM**
- d) SO course February, DvH and AR to sit in to see how presented with notes and guidelines and add feedback/comments. **LM**
- e) TENEX trained SO's at TENEX, no details of who was trained although requested. LM did not follow up, NH will do. **NH**
- f) Requests from clubs for SOI's –hold off training until new rules come in, expected by end March. **LM**
- g) DMG Safety Officers – must do DMG course, normal SO's & SOI's **LM**

**6. ADDITIONAL ITEMS**

6.1 Shotgun classifier – FBGC worked out shotgun classifier, reservations. Basic good idea, concern 20m distance will not shoot plates down to score. Weight of plates important. Clays expensive if used as targets. Clay target Stands would have to be standardized for consistency. Not all clubs have enough Plates/poppers available to present shotgun classifier. **ALL**

- **2013 IDPA AFRICA CHAMPS** – include word IDPA to attract overseas competitors. **NvdN/DVH**
- Match sanction forms handed to MH for Champs and DMG Nationals. Payment will be made to Ross & Jacobz with forms for submission. **MH**
- On line match application form will be available on website within one week. **NvdN**
- Novices will not be allowed to participate in 2013 IDPA AFRICA Champs **ALL**
- **DMG NATIONALS** : Date confirmed for IDPA SOUTH AFRICAN DMG AFRICA 22-23-24 November 2013. **ALL**

6.4 2013 CALENDAR changes made, PREMIER club added.

**NORTHERN CAPE DEFENSIVE PISTOL CLUB** – NH notified Kobus Burger that NCDPC will cease to exist as a SADPA club, reasons for this decision s per per previous minutes. **NH**

**DELAREY** – NH would phone Riaan Kriel concerning November shoot that did not happen but for which scores were submitted. SMS went out on Friday cancelling shoot due to the wind factor. It was felt that members who said they had participated should have their DSS revoked? Possible disciplinary action could be taken against DELAREY Defensive Pistol Club. **ALL**

- 6.5 Meeting combined shooting sports December – did not happen. SADPA would not pursue. **NH**
- 6.6 FEES – Juniors R100 – Seniors 60 years of age and older R100.00 Annual discounted fee from 1 September R250.00. 1<sup>st</sup> January R350.00. **MH**
- 6.7 SADPA Junior Squad, looking for CDP junior. Marketing idea to encourage junior members to shoot. **PO**
- 6.8 SADPA Ladies DMG squad, discussion with Geoff Hussey. AR15 rifles donated by HONEY BADGER. Must have full commitment from participants, must meet the criteria and cannot abscond. Purely a marketing endeavour to attract more women to the sport and DMG in particular. Should selected member either stop shooting DMG or not renew membership, they would have to return the rifle and other sponsored equipment. **ALL**
- 6.9 DSS list almost ready, will send to AR who will hand deliver to Brigadier. **NvdN**
- 6.10 EXCO positions available for election at AGM according to Constitution. All other EXCO members indicated a willingness to serve the second year of their term of office on the SADPA Exco. **NH**
- 6.11 **ANNUAL GENERAL MEETING** - date changed to 9<sup>th</sup> March – venue PDPC. Notice for this meeting must go out 21 days before the meeting. Include notification that there will be a shoot after the AGM. Persons nominated for positions must accept nomination prior to AGM. Members who paid after 28<sup>th</sup> February and wanted to vote or submit a Proxy to provide proof of payment. **MH**

 NH requested that all Exco members prepared reports to be presented at the AGM as per SADPA Constitution. **ALL**
- 6.12 **SOUTHERN NATIONALS 2013 – 21<sup>st</sup> and 22<sup>nd</sup> March.** No request for sponsorship received as yet by PO. COF's not received, DvH to request. AR asked who from SADPA Exco would attend? Suggested that travel and accommodation costs be covered by SADPA for exco members willing to attend. Gauteng entries would not be subsidized. **ALL**
- 6.13 **Rifle classifier.** NH expressed concern about safety aspect of facing up range with loaded rifle for average member. Majority of Exco felt that this could be done safely and the SO could prevent any unsafe handling with the long gun fairly easily. **AR**
- 6.14 **CAMARGUE** –recommended insurance payment made earlier in the year to avoid financial bottleneck with expenditure for major events. This would not happen Again as hosting clubs were carrying the cost of major event. **MH**  
 AR had approached CAMARGUE regarding non members being allowed to shoot one match – awaiting response from Advocate. **AR**
- 6.15 MH authorised to obtain **3g contract** as TELKOM line problematic.
- 6.16 **PROVINCIAL Colours** – AR asked that serious consideration be given to this as It would be good for the association. **AR**
